The first phase of the facility to be operational by the end of 2024; to serve Auto & Engineering customers in the region~

Pune, January 22, 2024: Mahindra Logistics Limited (MLL), one of India's largest integrated logistics solutions providers, announced the ground breaking of its state-of-the-art warehousing facility in Phaltan, near Pune. Encompassing an expansive area of 6.5 lakh sq. ft., this facility will be developed in two phases. The first phase, comprising 3.5 lakh sq. ft., is scheduled to be operational by the end of 2024.

Spread over an area of 25 acres at Phaltan, the new facility will be an important part of Mahindra Logistics Ltd. nationwide network of multi-client facilities.
