Limited ceased to be a subsidiary of Mahindra & Mahindra Limited (Promoter) of the Company, and, therefore, is no longer a promoter group company of Mahindra Logistics Limited under the SEBI (Issue of Capital and Disclosure Requirements) Regulations, 2018. f. On 30 September 2025, Mahindra & Mahindra Limited (Promoter) sold its entire stake in Sampo Rosenlew Oy (Sampo). On 14 August 2025, Mahindra & Mahindra Limited (Promoter) had sold its entire stake in Mahindra Ideal Lanka (Private) Limited (MILPL). As a result, MILPL ceased to be an Associate Company of the Promoter and, therefore, is no longer a promoter group company of Mahindra Logistics Limited under the SEBI (Issue of Capital and Disclosure Requirements) Regulations, 2018. h.
